### **GIVING QUOTED SHARES**

Making a gift of stocks, shares and other investments to charity has long been a popular method of giving. Giving quoted shares can benefit the Maritime Air Trust and you pay less tax.

E.g. If you were to give quoted shares valued at £1,000 (and were paying income tax at 40%) you could claim up to £400 income tax relief as well as a capital gains tax saving of up to £400. Thus, the maximum tax saving could be £800 a full 80% of the value of the shares!

You may also wish to sell your shares to the charity at less than the market value. For further details please contact the Treasurer.
